# Message from Craig A. McCain, FSA State Executive Director

As difficult as it is to continue our focus on this issue, the recent flooding and wet field conditions experienced across the State have severely impacted many aspects of agriculture. Some sources are estimating that upwards to 40,000 acres of corn have been damaged or destroyed by flood waters. Planting on untold acres has been delayed and to make matters worse, many producers are making very difficult decisions concerning continuing with their initial planting intentions or changing crops. Soil prep, pre-plant applications of fertilize and/or herbicides, seed availability and crop prices, along with potential timeframes of planting and the uncertainty of future weather, make these decisions even more challenging. In addition to crop damage or delay, many livestock producers across the State have reported loss of animals or feed during flash floods or prolonged flood events. Whatever the situation, I can attest that numerous elected officials, representatives of Southern and LSU Ag Centers, State and Federal agencies and producer groups

are working to assist our citizen farmers and ranchers who have been impacted. The Farm Service Agency is ready and willing to assist in communities across the State. While we pray and hope for favorable weather and better crop prices, we will continue to use the tools available to serve you.

If you have questions concerning potential disaster assistance or feel that you have a loss, please contact your local Farm Service Agency office as soon as possible to report the loss and discuss possible assistance. The Louisiana Agriculture Hall of Distinction honors those who have made significant contributions to the most important industry in Louisiana – Agriculture! Mr. Cooper was recognized for his notable contributions to the agri-business community and his unprecedented 42 years of service as the FSA State Executive Director for Louisiana.

### 2016 Acreage Reporting Dates

In order to comply with FSA program eligibility requirements, all producers are encouraged to visit their local FSA office to file an accurate crop certification report by the applicable deadline.

Acreage reporting dates vary by crop and by county so please contact your local FSA office for a list of county-specific deadlines.

The following exceptions apply to acreage reporting dates:

- If the crop has not been planted by the applicable acreage reporting date, then the acreage must be reported no later than 15 calendar days after planting is completed.
- If a producer acquires additional acreage after the applicable acreage reporting date, then the acreage must be reported no later than 30 calendars days after purchase or acquiring the lease. Appropriate documentation must be provided to the county office.
- If a perennial forage crop is reported with the intended use of "cover only," "green manure," "left standing," or "seed," then the acreage must be reported by July 15th.

Noninsured Crop Disaster Assistance Program (NAP) policy holders should note that the acreage reporting date for NAP covered crops is the earlier of the applicable dates or 15 calendar days before grazing or harvesting of the crop begins.

#### **USDA Regional Climate Change Hubs**

Agriculture Secretary Tom Vilsack established the first ever USDA Regional Climate Change Hubs in February 2014 at seven locations around the country to provide more information to farmers, ranchers and forest landowners on the increasing risks of fires, pests, floods, and droughts associated with a changing climate. # USDA Farm Service Agency (FSA) Online Hay and Grazing Acres Locator Tool

FSA's **Hay Net** website <u>www.fsa.usda.gov/haynet</u> is the "go to" online resource for agricultural producers to list information concerning the need for hay and grazing acres or the availability of hay and grazing acres.

If, due to extenuating circumstances, producers are in need of hay and/or grazing acres to support livestock, please use **Hay Net** to post an advertisement seeking these resources. Likewise, landowners who have hay and/or grazing acres available for livestock producers should post a Hay Net advertisement as well.

A few things to remember when using the **Hay Net** website:

- There is a one-time registration process that should be completed by all users who want to post an ad online.
- Users who just want to browse ads DO NOT NEED to have an eAuthentication user id.
- Hay and grazing acre ads will be automatically removed after a period of 13 months.
- Please help your fellow farmer and rancher by keeping ads current and up to date and remove
  ads you no longer need or want advertised on Hay Net. Please, no corporate advertisements
  on this site.

#### **Changing Administrative Counties**

Producers who wish to transfer their farm records to a different administrative county for Fiscal Year (FY) 2016 must file a request no later than August 1, 2016. Restrictions do apply when transferring to an office other than the county in which the land is physically located. Contact your local FSA office for more information.

#### **Loan Servicing**

There are options for Farm Service Agency loan customers during financial stress. If you are a borrower who is unable to make payments on a loan, contact your local FSA Farm Loan Manager to learn about the options available to you.

## **Loans for Targeted Underserved Producers**

FSA has a number of loan programs available to assist applicants to begin or continue in agriculture production. Loans are available for operating type loans and/or to purchase or improve farms or ranches.

While all qualified producers are eligible to apply for these loan programs, FSA has provided priority funding for members of targeted underserved applicants.

A targeted underserved applicant is one of a group whose members have been subjected to racial, ethnic or gender prejudice because of his or her identity as members of the group without regard to his or her individual qualities.

For purposes of this program, targeted underserved groups are women, African Americans, American Indians, Alaskan Natives, Hispanics, Asian Americans and Pacific Islanders.

FSA loans are only available to applicants who meet all the eligibility requirements and are unable to obtain the needed credit elsewhere.

#### **Attention Apple Users**
