
We are pleased to bring you a special statewide newsletter from USDA Farm Service Agency (FSA) to notify you of important programs and deadlines. Call and/or visit your local FSA office for more information about FSA's farm programs and farm loans.

2014 and 2015 ARC-PLC Enrollment: Enrollment into the Agriculture Risk Coverage (ARC) and Price Loss Coverage (PLC) programs for 2014 and 2015 began June 17, 2015, and will end Sept. 30, 2015. For ARC-CO and PLC, the contract enrollment must be completed by those producers with an interest in the base acres of the farm. For ARC-IC farms, the contract enrollment must be completed by producers who have an interest in the planted acres of the covered commodities on the farm. Contract enrollment is a separate process from program election which was completed earlier this year. Contact your local FSA office to schedule an appointment to enroll your farms into ARC or PLC by the deadline of **Sept. 30, 2015.**

2016 Noninsured Crop Disaster Assistance Program (NAP): NAP provides

financial assistance to producers of non-insurable crops when low yields, loss of inventory, or prevented planting occurs as the result of natural disasters. The 2014 Farm Bill expanded NAP to include buy-up coverage levels, similar to buy-up provisions offered by crop insurance. Producers may elect additional coverage levels ranging from 50 to 65 percent of production, in 5 percent increments, at 100 percent of the average market price. Producers who elect additional coverage must pay a premium in addition to the service fee. Crops intended for grazing are not eligible for additional coverage. Beginning, limited resource and underserved producers are eligible for a waiver of the service fee and a 50 percent premium reduction. 2016 NAP Coverage Continued on Pg. 2

2015 Livestock Forage Disaster Program (LFP): LFP provides compensation to eligible livestock producers who suffered grazing losses due to a qualifying drought or fire on

federally managed land. Eligible livestock producers must own or lease grazing land or pastureland physically located

in a county affected by a qualifying drought during the normal grazing period for the county. The following counties met the drought criteria; as of Aug. 27th qualifying producers with land in these counties are eligible for four monthly payments: **Beaverhead**, **Deer Lodge**, **Flathead**, **Glacier**, **Granite**, **Lake**, **Lewis and Clark**, **Lincoln**, **Mineral**, **Missoula**, **Pondera**, **Powell**, **Ravalli**, **Sanders and Silver Bow**. Qualifying livestock producers in **Jefferson**, **Teton and Toole** are eligible for three monthly payments and producers in **Madison** County are eligible for one monthly payment. Producers must complete an application and provide supporting documentation for 2015 losses by Feb. 1, 2016. <u>Please</u> <u>contact the local FSA office ASAP to schedule an appointment to begin the</u> <u>application process</u>.

Conservation Reserve Program (CRP) General Signup: USDA has announced that FSA will conduct a CRP General Signup from Dec 1, 2015 to Feb. 26, 2016. Producers can submit general signup offers to FSA during that time period. Continuous CRP applications are accepted on an ongoing basis. 2016 NAP Coverage Continued Applying for Coverage

Eligible producers must apply for coverage on eligible non-insurable crops using form CCC-471, "NAP Application for Coverage," and pay the applicable service fee at the FSA office where their farm records are maintained. The application and service fee must be filed by the application closing date. Application closing dates vary by crop and are established by the FSA State Committee. Producers who apply for NAP coverage acknowledge that they have received the NAP Basic Provisions, available at local FSA offices and at http:// www.fsa.usda.gov/nap.

2016 Crop Year Sales Closing Dates

Sept. 1, 2015: 2016 NAP Application Closing Date for Value-Loss Crops

Sept. 30, 2015: 2016 NAP Application Closing Date for Annual Fall-Seeded Crops, Perennial Forage and Grazing, Mixed Forage Crops, Rye, Speltz, Triticale, Wheat and Garlic

Dec. 1, 2015: 2016 NAP Application Closing Date for Honey Producers

March 15, 2016: 2016 NAP Application Closing Date for All Other Crops

Service Fees and Premiums

For all coverage levels, eligible NAP producers must pay a service fee of the lesser of \$250 per crop or \$750 per producer per administrative county, not to exceed a total of \$1,875 for a producer with farming interests in multiple counties. Producers who elect additional coverage must also pay a premium equal to:

For value loss crops, premiums will be calculated using the maximum dollar value selected by the producer on form CCC 471, "NAP Application for Coverage." The maximum premium for a producer is \$6,563 (the maximum payment limitation times a 5.25 percent premium fee).

Beginning, limited resource, and underserved producers are eligible for a waiver of the service fee and a 50 percent premium reduction when they file Form CCC-860, "Socially Disadvantaged, Limited **Resource and Beginning Farmer or Rancher**

Coverage Levels

Basic CAT Coverage: NAP provides catastrophic level (CAT) coverage based on the amount of loss that exceeds 50 percent of expected production at 55 percent of the average market price for the crop.

Additional Buy-Up Coverage: The 2014 Farm Bill authorized additional coverage levels ranging from 50 to 65 percent of production, in 5 percent increments, at 100 percent of the average market price. Additional coverage must be elected by a producer by the application closing date. Producers who elect additional coverage must pay a premium in addition to the service fee. Crops intended for grazing are not eligible for additional coverage.

Eligible Causes of Loss

Eligible causes of loss include the following natural disasters:

- Damaging weather, such as drought, freeze, hail, excessive moisture or wind;
- Adverse natural occurrences, such as earthquake or flood; and
- Conditions related to damaging weather or adverse natural occurrences, such as excessive heat, plant disease, volcanic smog (VOG) or insect infestation.

The natural disaster must occur during the coverage period, before or during harvest, and must directly affect the eligible non-insurable crop.

Organic Option for NAP

Beginning in crop year 2016, Montana producers may elect an Organic Option for some crops that qualify as "organic" according to the National Organic Program regulations and for which FSA has established a separate organic average market price. NAP coverage based on organic average market prices is available under both basic 50/55 coverage and buy-up coverage for eligible crops. Community Supported Agriculture (CSA) Operations and NAP

With the passing of the 2014 Farm Bill, certain Community Supported Agriculture (CSA) operations are now eligible to obtain NAP coverage. Subscription Community Supported Agriculture Operations are eligible to obtain NAP coverage. These operations are farmer-driven operations where the farmer owns or leases the farm, organizes the CSA, produces the farm products, and recruits the customer members or subscribers. Ongoing Notice of Loss Requirements:

- **NAP:** Submit Notice of Loss with FSA within 15 calendar days of the <u>earlier</u> of a natural disaster occurrence, the final planting date if planting is prevented by a natural disaster, the date that damage to the crop or loss of production becomes apparent; or the normal harvest date.
- **ELAP:** Submit Notice of Loss the <u>earlier</u> of 30 calendar days of when the loss is apparent or Nov. 1st after the end of the program year in which the loss occurred.

Livestock Indemnity Program (LIP): Submit Notice of Loss <u>within</u> 30 calendar days of when the loss is apparent. **Tree Assistance Program (TAP):** Final Date to Submit an Application and Supporting Documentation is the later of 90

calendar days of the disaster event or the date when the loss is apparent.

Farm Service Agency's 2015 County Committee Elections will begin across Montana in early November with election ballots being mailed to eligible voters. Ballots are due back to the local FSA office either via mail or in person by Dec. 7, 2015. Newly elected committee members and alternates will take office on Jan. 1, 2016.

FSA Payments in Montana - FY 2014

In fiscal year 2014 (Oct. 1, 2013 to Sept. 30, 2014), Montana FSA administered \$316.5 million in federal program payments and loans to Montana farmers and ranchers. That figure includes \$126.6 million in commodity loan and program payments, \$71.4 million conservation payments, \$30.7 million in disaster assistance and \$87.9 million in farm loans. So far in fiscal year 2015, FSA in Montana has funded 162 loans to beginning producers for more than \$14.2 million. Visit us online for the FY'14 report summary.
