## **Emergency Forest Restoration Program**

The Emergency Forest Restoration Program provides technical and financial assistance to private non-industrial forest landowners to carry out emergency measures to restore land damaged by a natural disaster. Available funding for EFRP is determined annually by Congress.

This program is implemented by several agencies working in coordination to assist landowners.

- FSA has overall program authority and responsibility to administer the program and agreements. FSA requests funds for the program based on needs of landowners and presidential declarations of disaster. FSA enters into an interagency agreement with US Forest Service
- 2. USDA funds go to US Forest Service, which enters into funded agreements with the State (in WA usually Department of Natural Resources). As requested by FSA, US Forest Service provides grants for technical assistance to State forestry agencies for assistance to owners of nonindustrial private forest land (forest owners) to carry out emergency measures to restore the land that was damaged by a natural disaster.
- 3. The State agency (DNR) either does the work directly or hires private sector technical assistance providers. The State forestry agencies assure that all technical work to restore eligible land meets State Forestry standards.

There is an Interagency Agreement in place between US Forest Service and FSA outlining provisions for implementing the program. Document can be provided at a later date. Below is a link to a fact sheet.



# **Temporary Grazing Permits on National Forest System Lands**

US Forest Service grants permits for grazing on national forest system lands. Land allotments designate where grazing can occur. Some allotments are vacant (there is currently no permit holder actively grazing the land). USFS can grant a temporary one year grazing permit to ranchers and herders to use vacant allotments in emergency conditions.

USFS still has to comply with various regulatory requirements, including NEPA. Someone who would like to use USFS grazing land can submit a request to the line officer that oversees the allotment (usually a District Ranger).

Attached is a map with current vacant allotments. Also attached is the application form for a temporary permit.
